



REQUEST FOR EXPRESSION OF INTEREST FOR SUPPLY OF CASH COUNTING MACHINE

1. INTRODUCTION AND BACKGROUND

Safaricom Ethiopia, licensed to provide unified telecommunications services in Ethiopia, intends to roll out, deploy and expand the network, regional offices, and shops amongst other facilities. This is to meet the intended subscriber base and enterprise clients. To meet this objective Safaricom Telecommunications seeks to partner with competent suppliers and service providers for the supply of various goods and services.

To this end, Safaricom intends to engage the services of a reputable supplier/s for the supply of Cash Counting Machines for the use of retail shops. Safaricom is therefore soliciting Expressions of Interest (EOI) from interested qualified suppliers.

2. THE EOI

This EOI is intended to identify reputable and qualified suppliers who will be able to deliver the Cash Counting Machine (but is not limited to) below:

1. Provide readily available in stock including consumables/spare parts
2. Provide aftersales and maintenance services

The full details of the scope of the Cash Counting Machine will be provided in an RFP (Request for Proposal) that will be sent out to bidders shortlisted through this EOI process.

8	A basic technical proposal to satisfy the requirements by Safaricom to the extent detailed in this EOI document under item 4 below.
9	Past two/three years audited financial data /accounts.
10	Any additional information that Safaricom should be aware of

Interested suppliers should submit their responses on the following with a range of Counting machines, based on size, capacity, speed of counting, band, quality certification, and so on.

- Review of submitted Expressions of Interest.

- Awarding the successful bidder.
